<input type="checkbox"/>	<b>I am a non-citizen who entered the U.S. after turning 26</b> <b>- OR -</b> <b>I entered the U.S. as a lawful non-immigrant</b> on a valid visa and remained in the U.S. when I turned 26 or older.	<ol style="list-style-type: none"> <li><b>SUBMIT</b> copy of your birthdate from a driver's license or state ID, birth certificate or passport - <b>AND</b> –</li> <li><b>SUBMIT</b> documentation of immigration entry date into the U.S.: <ul style="list-style-type: none"> <li><input type="radio"/> <b>For entry after age 26</b> – A date stamp on the I-94 form; OR a dated passport immigration stamp</li> <li><input type="radio"/> <b>For proof of status in U.S. until you turned age 26</b> – A letter from the U.S. Citizenship and Immigration Service *USCIS) indicating your entry date; OR a student visa form (I-20) or other valid U.S. passport visa stamp. A Resident Alien Card (Green Card) is not sufficient proof of date of entry.</li> </ul> </li> </ol>
<input type="checkbox"/>	<b>I am a male U.S. citizen, permanent resident alien, refugee or political asylee age 26 or older</b> , who did not register for selective service as required by law. Eligibility for assistance will be determined by the Financial Aid Office based on documentation provided – ignorance of the law is not excusable.	<ol style="list-style-type: none"> <li><b>SUBMIT</b> a Status Information Letter from Selective Service – request a letter at <a href="http://www.sss.gov">www.sss.gov</a> – <b>AND</b> –</li> <li><b>SUBMIT</b> a typewritten explanation describing your failure to register for selective service, including any extenuating circumstances and whether you knowingly or willfully failed to register as required by law.</li> </ol>

<input type="checkbox"/>	<b>I was born a female and am not required to register.</b>
<input type="checkbox"/>	<b>I was born before 1960 and was not required to register.</b>
